The Kerala State Coir Corporation Ltd invites tenders from experienced civil contractors for the laying of interlock paver blocks in front of Stencilling unit at Head Office of the Kerala State Coir Corporation Ltd,Alappuzha. Tender should be including quoted rate signed and sealed by the contractor as per the technical specification.

GST should be mentioned separately

1. SCOPE OF WORK

The scope of work is to lay interlock paving in front of stencilling unit as per the specifications along with the tender.

2.TECHNICAL CONDITION

The bidder should submit work order/ completion certificate of minimum two works from the client Showing experience in similar works.

3. TENDER DATES

4. TENDER FEE

Cost of tender document Rs.**1000/-**(Inclusive of GST) should be paid at KSCC cash counter and the receipt of the same should be placed along with the tender /the bidder can pay it as Demand Draft in favour of “Managing Director, The Kerala State Coir Corporation Ltd”, payable at Alappuzha, in such cases the DD should be submitted along with the tender.

Tender fee is non-refundable in any case

5. Earnest Money Deposit

An EMD amount of Rs. **3000/-** should be paid by the bidder. The EMD shall be paid as Demand Draft in favour of "Managing Director, The Kerala State Coir Corporation Ltd" payable at Alappuzha. OR the EMD amount can be paid at KSCC cash counter and receipt of the same shall be placed along with the tender. In the case of bidders whose bids are not considered for placing order, the Earnest Money Deposit (EMD) will be refunded without any interest within 30 days from the date of issue of work order to the successful bidder.

The EMD of the successful tenderer will be considered as the security deposit, and which will be released only after the successful completion of work.

If the successful tenderer disagree to execute the work/fails to complete the work within the specified period, EMD will paid be forfeited.

All registered MSMEs in the state of Kerala and having Udyog Aadhar registration or registration from any of the bodies specified by the Ministry of Micro,Small and Medium Enterprises will be exempted from the payment of EMD and Tender cost.

6.PRICE

- a. The bidder should submit rate for the interlock paving bricks work as specified in the tender document
- b.No additional charges will be given other than the quoted amount
- c.Applicable GST should be mentioned in the Price Bid
- d.The comparison of the rates offered shall be on the basis of the total rates offered inclusive of all taxes.
- e.The price quoted should be valid for a period of 12 months from the date of opening of tender.
- f.The quoted price shall be fixed and firm and escalation on any account shall not be acceptable.

7.PAYMENT TERMS

- 1.No advance payment will be released for the work
- 2.Payments will be released against the submission of bills submitted against the completion of works
- 3.Necessarry TDS will be deducted from the bill
- 4.Even though the quantity mentioned in the schedule of works. The final bill amount will be finalized based on the actual measurement of work done at the site

8.DETAILED SCOPE OF WORK

Scope of work is to level and ram the ground so as to make the ground level even and ready for laying the interlock block.Lay the interlock block as per the specification in the tender document. Salient terms and conditions of the works are noted below

- 1.The work should be done strictly as per the specifications of every work
- 2.The work should be supervised by an experienced person.
- 3.Materials,Labour and necessary equipment for the work shall be arranged by the contractor.
- 4.It is the responsibility of the contractor to mobilize the materials required for the work.Loading and unloading of materials are under the scope of the contractor.

Details of the works are noted below:-

1.The quantity mentioned are tentative and it can increase or decrease as per the requirement of company at the time of work. Even though final bill will be calculated as per the actual measurement of the work done.

The leveling work is in lumpsum, and the contractor should visit the site and confirm the area and quantity of the leveling works before submitting the rates.

9. GUARANTEE OF THE WORK

The contractor should guarantee the work for a period of 12 months from the date of completion of the works. Any damages happens to the works due to the poor quality of the work shall be rectified by the contractor without any additional cost.

10. PERIOD OF COMPLETION OF THE WORKS

All the works related mentioned in the tender document shall be completed within the 10 days from the date of acceptance of work order.

GENERALCONDITION:

1.Kerala State Coir Corporation Ltd reserves the right to call for any further information. Any information furnished by the agency found to be incorrect at any stage would render their proposal being declared ineligible.

2.Kerala State Coir Corporation Ltd shall not be responsible for any postal delay. Incomplete applications may summarily lead to rejection.
